

**COUNCIL ORGANIZATIONAL MEETING MINUTES**  
**Monday, January 4, 2016 – 8:00 P.M.**

APPOINTMENT OF COUNCIL STANDING COMMITTEES FOR 2016


President Swan indicated that committee appointments would be made later in the month.
