



RICHFIELD PARKS AND RECREATION
BOARD MEETING
FEBRUARY 3, 2016
MINUTES

The Richfield Village Parks and Recreation Board meeting was called to order at 7:05 p.m.

ROLL CALL: Burlotos, Daniels, Kovak, Daniels, Stulak and Keske. Also present Councilperson Healey and Mayor Beshara.

APPROVAL OF MINUTES: A MOTION was made by Daniels and second by Keske to approve the February 3, 2016 minutes as corrected. Motion approved.

The Mayor swore in Brian Stulak for a 4 year term.

DIRECTOR'S REPORT: Jocek reported that she just came back from the OPRA conference and that it was productive in information and in networking. She also looked at potential playground pieces for the Town Hall playground. Jocek presented the board with pictures of the pieces and she informed them that the company offered a special price for these pieces. One piece is a swing for little ones that faces the adult on their swing. The other piece is a swing that resembles a "tire" swing but is flat and a few children can swing at the same time.

Jocek informed the Board that the Art Show and the Easter Egg Hunt is on the same day this year due to an early Easter. The date is Saturday, March 19, 2016. The Art Show starts at 10 am and the Easter Egg Hunt starts at 11 am.

The Recreation Department is holding a second Open House on Saturday, February 20th, 2016 at 10:30 am. Jocek invited everyone to stop in.

MAYOR'S REPORT: Mayor Beshara stated that she is going to have a meeting with UA in regards to the Mayor's Fitness Challenge. It should start in April.

Beshara is working with Gina R. on her quarterly news letter which will come out in April.

The Mayor is planning to perform weddings on Sunday, Valentine Day. She believes she has one couple so far.

The Township moved out of the brick house behind the police department and hopefully it will be torn down in the near future as planned.
