

RESOLUTION NO. 55-2010

A RESOLUTION ADOPTING THE UNIFORM AND CLOTHING ALLOWANCE FOR 2011 AND DECLARING AN EMERGENCY

WHEREAS, Section 153.12 of the Administration Code provides that Council, on an annual basis, shall provide for the maintenance and replacement of clothing and equipment for Village employees; and

WHEREAS, the Mayor has recommended the clothing allowance for the year 2011.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the following shall be the annual allowance for clothing and uniforms for employees for the Village of Richfield:

Full-time Police	\$950 Annually
Full-time Fire	\$1,000 Annually
Part-time Police	\$525 Annually
Part-time Fire	\$150 Annually
Full-time Dispatcher	\$525 Annually
Part-time Dispatcher	\$300 Annually
Dog Warden	\$100 Annually
Service Department	\$400 Annually
Service Director	\$200 Annually
Planning & Zoning Director	\$200 Annually
Janitor	\$150 Annually

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to provide for replacement and clothing for Village employees to carry out Village functions at the earliest possible time; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
