**A RESOLUTION AUTHORIZING THE MAYOR AND FINANCE DIRECTOR TO ENTER INTO AN AGREEMENT WITH GPD GROUP FOR PROFESSIONAL ENGINEERING SERVICES FOR THE PERIOD 2016-2017**

WHEREAS, the prior agreement between the Village of Richfield and GPD Group for Village Engineer services has expired; and

WHEREAS, GPD Group has proposed an increase in the hourly rates for services contained in Section 2.1(c) of the agreement, as set forth below:

SECTION 3. This Resolution shall take effect and be in force from and after the earliest period allowed by law.
