A RESOLUTION AUTHORIZING THE MAYOR AND FINANCE DIRECTOR TO ENTER INTO A CONTRACT FOR AUCTIONEER SERVICES WITH EDWARD P. PFISTER III – AUCTIONEER

WHEREAS, approximately every three (3) years the Village assembles a list of personal property that is no longer needed for public use, is obsolete or is unfit for the use for which it was acquired, and, after presentation to Council, is deemed surplus property available for sale at public auction; and

WHEREAS, at this time, it is anticipated that certain personal property will be deemed surplus property by this Council to be sold at public auction; and

WHEREAS, this Council desires to authorize the Mayor and Finance Director to engage Edward J. Pfister III for auctioneer services to conduct a public auction on or about August 27, 2016 of any Village personal property that is deemed surplus property by this Council.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the Mayor and the Finance Director be, and they hereby are, authorized and directed to enter into a contract with Edward P. Pfister III for auctioneering services for personal property subsequently deemed surplus property by the Village Council, on substantially the same terms as the contract attached hereto and incorporated herein by reference as Exhibit "A".

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Resolution shall take effect and be in force from and after the earliest period allowed by law.
