

**A RESOLUTION TO AUTHORIZE WARRANT FOR PAYMENT BASED ON THEN AND NOW CERTIFICATE FOR PURCHASES, AND DECLARING AN EMERGENCY**

**WHEREAS**, Ohio Revised Code Section 5705.41 (d) provides a process for a Village Council, as a political subdivision of the state and a taxing unit, to authorize Then and Now Certificates to cover financial commitments made to vendors or other parties by the Village prior to a Fiscal Officer Certification, through formal purchase order or otherwise; and

**WHEREAS**, this Council has received from the Village Finance Director within the prior thirty (30) days certifications, with respect to the items listed in Section 1 of this Resolution, that there was at the time of the making of such contracts or order and at the time of the execution of such certificates a sufficient sum appropriated for the purpose of such contracts and in the treasury, or in process of collection, to the credit of an appropriate fund free from any previous encumbrances; and

**WHEREAS**, Council now desires to authorize the drawing of a warrant in payment of the amounts due upon such contracts or orders.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Village of Richfield, State of Ohio:

Section 1. That the drawing of a warrant in payment of the following amount due is hereby authorized:






the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
