

**A RESOLUTION AUTHORIZING THE MAYOR AND THE FINANCE DIRECTOR TO CONTRACT FOR THE PURCHASE OF ROAD SALT FROM AMERICAN ROCK SALT COMPANY, LLC PURSUANT TO THE COMMUNITY UNIVERSITY EDUCATION (C.U.E.) PURCHASING ASSOCIATION PROGRAM FOR THE 2018-2019 WINTER SEASON AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Richfield, as a member of the C.U.E. purchasing program, may purchase road salt under the C.U.E.'s public bidding procedures; and

WHEREAS, on October 16, 2018, this Council passed Resolution No. 81-2016 to contract with Mid-American Salt through the C.U.E. program for the 2018-2019 winter season; and

WHEREAS, the Service Director has been informed by the C.U.E. Secretary/Treasurer that Mid-American Salt is no longer able to fulfill its commitment under the previous agreement; and

WHEREAS, the C.U.E. program has been able to obtain a commitment from American Rock Salt Company to provide the previously contracted amount of road salt to C.U.E. members at a price of \$105.00 per ton for delivery through December 15, 2018 and \$115.50 per ton for delivery through March 31, 2019, in accordance with the quotation attached hereto as Exhibit A; and

WHEREAS, the Service Director has recommended purchasing of road salt from American Rock Salt Company, LLC through the C.U.E. program for the 2018-2019 winter season.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio, that:



SECTION 1. That Resolution No. 81-2018, passed by this Council on October 16, 2018, be and hereby is repealed.

SECTION 2. For the 2018-2019 winter season, the Mayor and the Finance Director are authorized and directed to purchase the Village's road salt requirements from American Rock Salt Company, LLC at \$105.00 per ton for delivery through December 15, 2018 and at \$115.50 per ton for delivery through March 31, 2019.

SECTION 3. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to procure needed road salt for the upcoming 2018-2019 winter season at the earliest possible time; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members


