A RESOLUTION ACCEPTING THE BID OF BECDIR CONSTRUCTION COMPANY FOR THE REPAIR OF THE BRECKSVILLE ROAD CULVERT PROJECT AND DECLARING AN EMERGENCY

WHEREAS, pursuant to advertisement, on October 25, 2017, bids were received by the Village of Richfield for the Brecksville Road Culvert Project; and

WHEREAS, based upon the review and award recommendation of the Village Engineer attached hereto as Exhibit A, the Service Director recommends the acceptance of the bid of Bedcir Construction Company as being the lowest and best bid.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the bid of Bedcir Construction Company in the amount of \$135,661.75 for the Brecksville Road Culvert Project, being the lowest and best bid, be, and the same hereby is, accepted.

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that the deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Revised Code of the State of Ohio.

SECTION 3. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to allow for this traffic safety project to proceed at the earliest possible time; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
