**A RESOLUTION AUTHORIZING THE MAYOR AND THE FINANCE DIRECTOR TO ENTER INTO AN AGREEMENT WITH VISION SERVICE PLAN FOR VISION INSURANCE FOR FULL-TIME VILLAGE EMPLOYEES.**

WHEREAS, the Village's Mayor has recommended entering into an agreement with Vision Service Plan to be the provider for vision insurance for full-time Village employees during the year 2012.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the Mayor and the Finance Director be, and they hereby are, authorized and directed to enter into an agreement with Vision Service Plan for the Village's vision insurance effective January 1, 2012, in accordance with the offer from VSP representative, Melinda Miller-Goldsmith, a copy of which offer is attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. In accordance with Section 4.12 of the Charter of the Village of Richfield, this Resolution No. -2011 shall take effect and be in force upon the approval of the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
