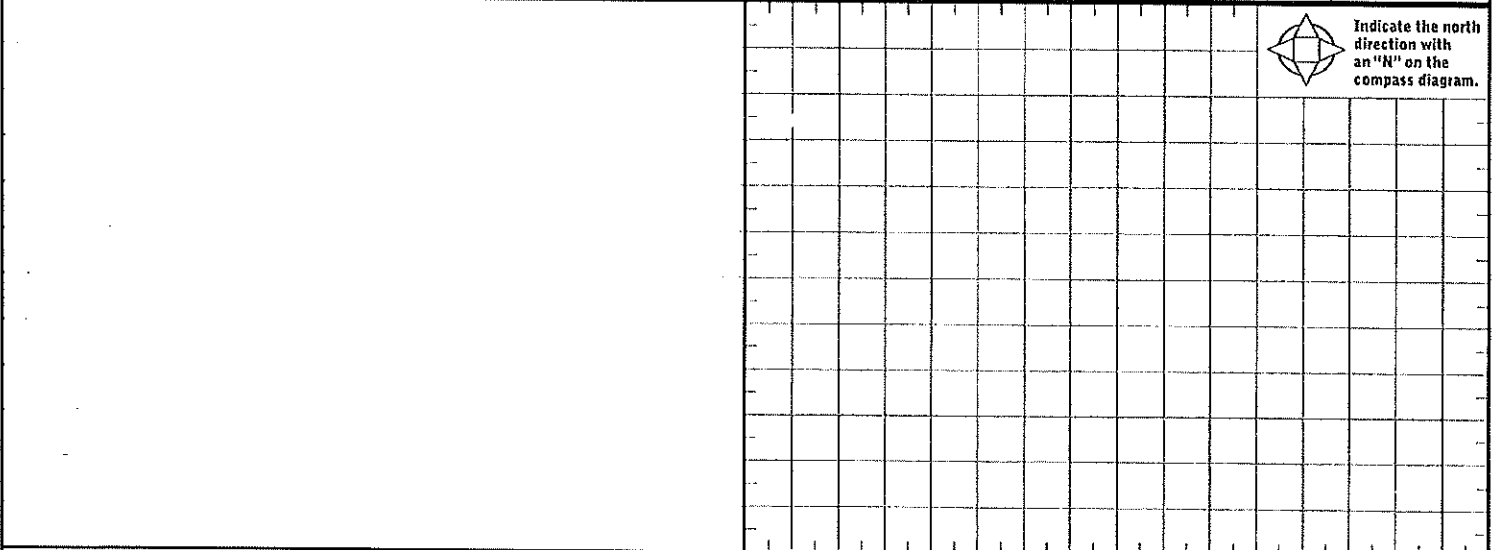

<p>On November 30th 2019 at 9:34am Unit 1, driven by Alfonso Miller, was exiting the north drive of the Pilot Flying J Travel Center located at 5219 Brecksville rd. Richfield. While Unit 1 was conducting his left-hand turn, he pulled out in front of Unit 2. Unit 2, driven by David Woods, was traveling west on Columbia rd. Unit 1's front right bumper came into contact with the back-left side of Unit 2. Both vehicles had minor damage and were still able to be driven. Officers cited Unit 1's driver, Mr. Miller, for fail to yield/ enter roadway (O.R.C 4511.44).</p> <p>Unit 1's driver stated that he proceeded out of Pilots truck stop with caution knowing there was a FedEx truck about 300 yards down the road to his east. Then before Unit 1 had even made it completely out of the truck stop drive Unit 2 had ran into the side of Unit 1.</p> <p>Unit 2's driver stated he was traveling east down Columbia road to turn left at the intersection of Columbia and Brecksville rd. As he was passing the exit for the truck stop Unit 1 started to pull out in front of him. 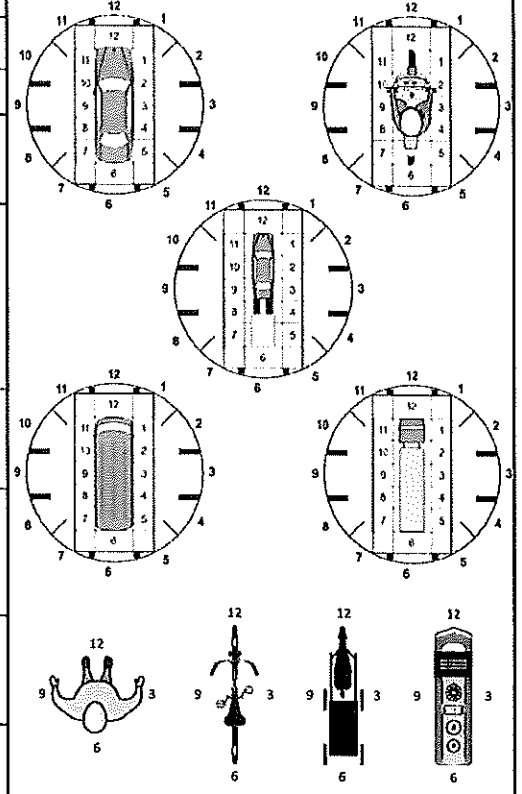

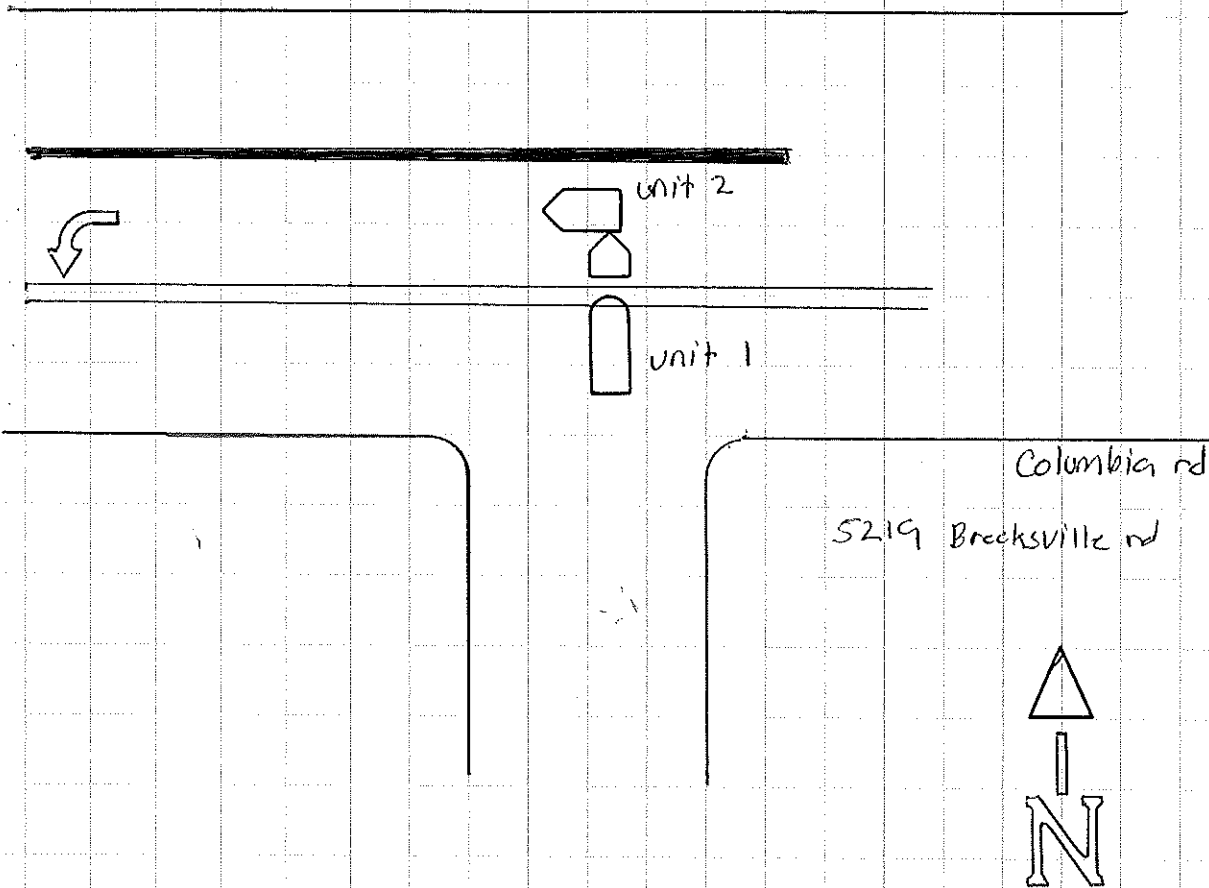
