A RESOLUTION AWARDING A CONTRACT TO NASON LANDSCAPING FOR SENIOR SNOWPLOWING DURING THE 2007-2008 WINTER SEASON AND DECLARING AN EMERGENCY

BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the Mayor and the Finance Director be, and they hereby are, authorized and directed to enter into an agreement with Nason Landscaping for senior snow plowing during the 2007-2008 winter season in accordance with the low bid of Nason Landscaping, a copy of which bid is attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to allow senior snow plowing during the fall/winter 2007-2008 season; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
