

**AN ORDINANCE AMENDING SECTION 339.02, "USE OF LOCAL STREETS; LOCAL PERMIT AND CONDITIONS" OF THE CODIFIED ORDINANCES OF THE VILLAGE OF RICHFIELD TO INCREASE THE LOCAL PERMIT FEE FOR MOVING OVERSIZED AND OVERWEIGHT VEHICLES UPON VILLAGE STREETS AND THE HOURLY RATE FOR POLICE OFFICERS NEEDED TO SUPERVISE THE MOVEMENT OF SUCH VEHICLES**

WHEREAS, Section 339.02 of the Codified Ordinances of the Village of Richfield requires individuals to obtain a permit from the Chief of Police in order to move oversized and overweight vehicles upon local Village streets; and

WHEREAS, the Ordinance permits the Village to charge \$10.00 for such permit and establishes a rate of \$25.00 for each hour of time or any part thereof spent by each police needed to supervise the moving of such vehicles; and

WHEREAS, the Administration has recommended that Council amended Section 339.02 of the Village's Codified Ordinances to increase the local permit fee to be in align with amount charged by other jurisdictions and to amend the police officer hourly rate to match the current police officer hourly rate charged for traffic control services; and

WHEREAS, Council determines that it is the best interest of the Village to amended Section 339.02 of the Village's Codified ordinances to increase the local permit fee from the current amount of \$10.00 to \$100.00 and to amend the current \$25.00 police officer hourly rate to match the current police officer hourly rate charged for traffic control services.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Richfield, County of Summit, State of Ohio that:

SECTION 1. Section 339.02, "Use of Local Streets; Local Permit and Conditions" of the Codified Ordinances of the Village of Richfield is hereby amended as follows:

**"339.02 USE OF LOCAL STREETS; LOCAL PERMIT AND CONDITIONS.**

- (b) Local Permit and Conditions. Upon application and for good cause, the Police Chief may issue a local permit authorizing an applicant to move an oversize or overweight vehicle or combination of vehicles upon local streets.

\*\*\*

For each such permit, the Police Chief shall charge ~~ten~~ one hundred dollars (~~\$10.00~~) (\$100.00), and for each hour of time or any part thereof spent by each

police officer in supervising the movement of such vehicle, the applicant shall pay the sum of twenty five dollars (\$25.00) per hour per officer current hourly rate for police officers providing traffic control services as determined, from time-to-time, by the Chief of Police. The charge can be prorated into fifteen minute increments.

SECTION 2. Section 339.02, "Use of Local Streets; Local Permit and Conditions" of the Codified Ordinances of the Village of Richfield as it existed prior to the effective date of this Ordinance is hereby repealed.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
