

A RESOLUTION AUTHORIZING THE MAYOR AND THE FINANCE DIRECTOR TO ENTER INTO AN AGREEMENT WITH VERMEER SALES & SERVICE, INC FOR THE PURCHASE OF A BRUSH CHIPPER AND DECLARING AN EMERGENCY

WHEREAS, pursuant to advertisement, the Service Director has recommended acceptance of the bid of Vermeer Sales & Service, Inc. for sale to the Village of a brush chipper as being the lowest and best bid.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the bid of Vermeer Sales & Service, Inc. in the amount of \$26,272.00, a copy of which bid is attached hereto as Exhibit "A" and incorporated herein fully as if by reference, being the lowest and best bid, be, and the same hereby is, accepted.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to be ready for the summer service season; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
