

A RESOLUTION ACCEPTING THE BID OF STONECO, INC. FOR ASPHALT AND DECLARING AN EMERGENCY

WHEREAS, pursuant to advertisement, bids were received for asphalt; and

WHEREAS, the Service Director recommends the acceptance of the bid of Stoneco, Inc. as being the lowest and best bid.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the bid of Stoneco, Inc. for sale to the Village of asphalt, a copy of which bid is attached hereto as Exhibit "A" and incorporated herein fully as if by reference, be, and the same hereby is, accepted as being the lowest and best bid.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to be available for the spring/summer construction season; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.






