

A RESOLUTION TO ADOPT THE SOLID WASTE MANAGEMENT PLAN FOR THE SUMMIT/AKRON SOLID WASTE MANAGEMENT AUTHORITY

WHEREAS, the Village of Richfield is located within the Summit/Akron Solid Waste Management Authority; and

WHEREAS, the Summit/Akron Solid Waste Management Authority Board of Trustees prepared and adopted a final draft of the Solid Waste Management Plan in accordance with Ohio Revised Code Sections 3734.53, 3734.54 and 3734.55; and

WHEREAS, the Summit/Akron Solid Waste Management Authority has provided a copy of the Draft Final Solid Waste Management Plan for ratification to each of the legislative authorities of the District; and

WHEREAS, the Village of Richfield must decide whether it approves of said Solid Waste Management Plan within ninety (90) days of receipt of the Final Draft Plan.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the Village of Richfield approves the Summit/Akron Solid Waste Management Authority Solid Waste Management Plan.

SECTION 2. That the Clerk is hereby directed to send the Authority a copy of this Resolution to the attention of Yolanda Walker, Executive Director, Summit/Akron Solid Waste Management Authority, 12 East Exchange Street, Third Floor, Akron, Ohio 44308.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. This Resolution shall take effect and be in force from and after the earliest period allowed by law.

Re: Ratification of The Summit/Akron Solid Waste Management Authority's Solid Waste Management Plan

The Summit/Akron Solid Waste Management Authority (Authority) Board of Trustees adopted the amended Solid Waste Management Plan on July 8, 2003. A complete copy of the amended Plan is enclosed. Ohio law (Ohio Revised Code 3734.55(B)) requires the Board of Trustees to deliver a copy of the adopted Plan to the County Council, and the legislative authority of each municipal corporation, village and township within the Summit/Akron Solid Waste Management District.

Within 90 days of receiving the Plan, the County Council and each municipal, village and township legislative authority shall approve or disapprove the draft plan by ordinance or resolution.

The Authority determines that the Plan has been ratified when a combination of municipal corporations, villages and townships with a combined population comprising 60 percent of the district has approved the Plan. That combination must include approval from the Summit County Council and the largest city in the district (City of Akron).

I have enclosed a sample ordinance/resolution that can be used by your community, and a copy of the ordinance/resolution used by your council to ratify the amended Plan in 1999 (if available). If you would like to have a copy of the sample ordinance/resolution emailed to you, please call the Authority at 330-374-0383.

Because of the 90-day timeframe (which cannot be extended) we would appreciate your immediate attention to this request. Please contact me if you have questions regarding the Plan or ratification procedures, or to schedule a time for me to speak with your council.

We look forward to hearing from you no later than 90 days from the date of this letter.
