

A RESOLUTION AUTHORIZING THE PURCHASE OF A 2004 FORD EXPLORER THROUGH THE CUE GROUP PURCHASING POOL AND DECLARING AN EMERGENCY

BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio, two-thirds of the members elected thereto concurring:

SECTION 1. That the Mayor and the Finance Director be, and they hereby are, authorized and directed to purchase a 2004 Ford Explorer 4-door from Montrose Ford through the CUE Group Purchasing Pool in an amount not to exceed \$23,449.12 for use by the Zoning Inspector in accordance with the bid attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to provide equipment for a necessary Village Department; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
