

A RESOLUTION ACCEPTING THE BID OF ACME COMPANY FOR SUPPLY TO THE VILLAGE OF LIMESTONE MATERIALS AND DECLARING AN EMERGENCY

BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the bid of Acme Company for supply to the Village of limestone materials from April 1, 2002 through March 31, 2003, being the lowest and best bid, be, and the same hereby is, accepted, a copy of which bid is attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to supply materials for the 2002 construction season; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

Road Repair and Maintenance Materials

- Limestone / Sand

As you can see from our bid tabulation sheet, the Village only received one bid for the lime stone materials. Acme has been the low bidder and only bidder for the last 2 years. The Village has worked well with Acme and is happy to continue with this company for limestone materials.

We use limestone materials for ditch eliminations, driveway culvert s, culverts and storm water drainage, and driveway aprons.

I respectfully request approval of this bid for limestone materials.

- Asphalt Emulsions

As you can see from our bid tabulation sheet, the Village only received one bid for asphalt emulsions. Cross Roads was this bid. We use this product for binder for driveway aprons and tar and chip patching. It is a very limited use.

I respectfully request approval of this bid for the asphalt emulsions as attached.

- Asphalt Sealant

As you can see from our bid tabulation sheet, the Village received two bids for asphalt sealants. DJL was the low bidder. DJL has been the asphalt sealant supplier for the last 2 years. The Village has worked well with DJL, and they are located only 8 miles from our shop. We look forward to caring on this working relationship.

We use these sealants for crack sealing; asphalt patching, and sealing driveway aprons at the street.

I respectfully request approval of this bid for asphalt sealant.

NOTE: As a reminder, our current contract for road repair and maintenance materials ends the end of March. Therefore time is of the essence for this approval to go through.
