

AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF THE VILLAGE OF RICHFIELD, STATE OF OHIO, AND CONFORMING TRAFFIC AND GENERAL OFFENSES CODE PROVISIONS TO STATE LAW CHANGES AND DECLARING AN EMERGENCY

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of the Village of Richfield, Ohio; and

WHEREAS, changes should be reflected in the Codified Ordinances to conform to statutory enactments of the Ohio General Assembly.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Richfield, State of Ohio:

SECTION 1. That the editing, arrangement and numbering of those ordinances and resolutions enacted by Council from 12-31-2020 to 3-31-21, and from 43-2021 to Res. 65-2021 as listed in the Comparative Section Table, are hereby approved and adopted as printed in the March 2021 and July 2021 Replacement Pages to the Codified Ordinances to as to achieve uniformity of style and classification. A copy of such Replacement Pages is attached to this ordinance and incorporated as a part hereof.

SECTION 3. All prior ordinances or parts thereof inconsistent with any provision of the ~~March~~ July 2021 Replacement Pages are hereby repealed.

SECTION 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the health, safety and welfare of the residents of Richfield Village, Ohio, for the reason that there exists an imperative necessity for the earliest publication and distribution of the ~~March~~ July 2021 Replacement Pages to the Codified Ordinances to the officials and residents of the Village, so as to facilitate administration, daily operation and avoid practical and legal entanglements; wherefore, provided this Ordinance receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
