

AN ORDINANCE AMENDING SECTION 921.05 OF THE STREETS, UTILITIES AND PUBLIC SERVICES CODE EXPANDING SEWER DISTRICT NO. 3

WHEREAS, pursuant to Ohio Revised Code Section 727.44, this Council enacted Section 921.05 of the Streets, Utilities and Public Services Code creating Sewer District No. 3; and

WHEREAS, the Service Director has been requested by the owners of properties located at 4137 and 4146 Streetsboro Road to be included within Sewer District No. 3; and

WHEREAS, this Council wishes to expand the boundaries of Sewer District No. 3 to allow the for expansion of the Sewer District and tie-in of the property.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Richfield, State of Ohio:

SECTION 1. That Section 921.05 of the Streets, Utilities and Public Services Code be amended to read as follows:

“921.05 SEWER DISTRICT NO. 3.

Pursuant to Ohio Revised Code Section 727.44, a district is hereby established to be known as Sewer District No. 3. The description of such District is prepared by Finkbeiner, Pettis & Strout, Ltd., the Village’s Consulting Engineer as approved and such District is described as follows: See Exhibit A.”

SECTION 2. That the Village’s Consulting Engineer, Finkbeiner, Pettis & Strout, be, and they hereby are authorized and directed to prepare a legal description of Sewer District No. 3 to include the properties located at 4137 and 4146 Streetsboro Road.

SECTION 3. That Section 921.05 of the Streets, Utilities and Public Services Code as it existed prior to the effective date of this Ordinance be, and the same hereby is, repealed.

SECTION 4. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.

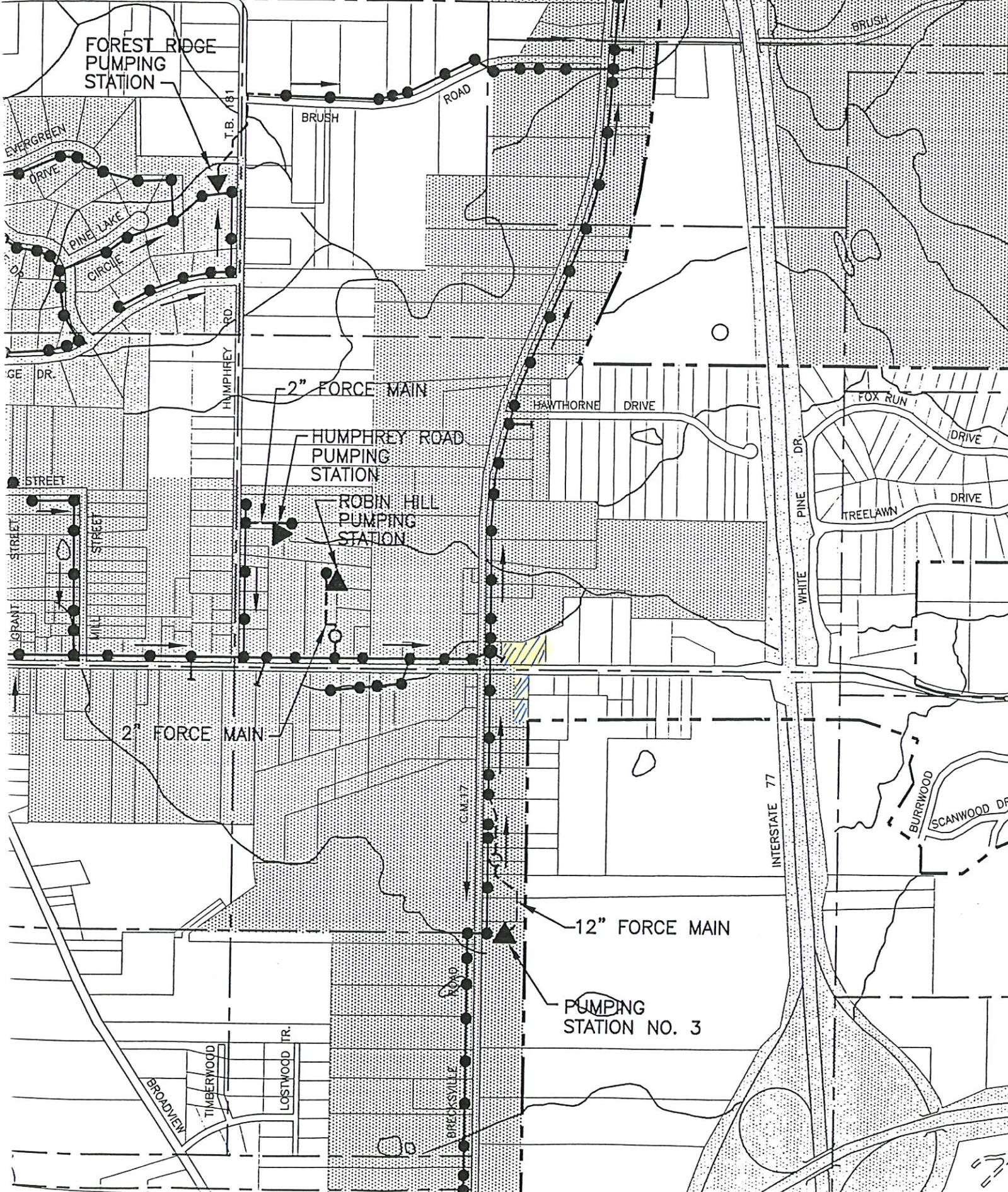
