

A RESOLUTION AUTHORIZING THE MAYOR AND THE FINANCE DIRECTOR TO PROVIDE FOR SNOW REMOVAL SERVICES FOR SENIOR CITIZENS AND DECLARING AN EMERGENCY

BE IT RESOLVED by the Council of the Village of Richfield, State of Ohio:

SECTION 1. That the Mayor and the Finance Director be, and they hereby are, authorized and directed to enter into an agreement with Steve Kasperski for snow removal services for senior citizens in accordance with the quotation attached hereto as Exhibit "A" and incorporated herein fully as if by reference in an amount not to exceed \$10,000.

SECTION 2. That this agreement is in accordance with the Village's 23rd year CDBG grant.

SECTION 3. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to be in effect for the winter season; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

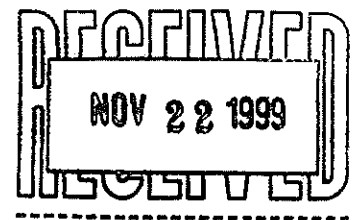

1. I, Steve Kasperski will plow the Village Seniors driveways as listed and provided by the Village of Richfield.
2. I, Steve Kasperski understand the maximum driveways to be plowed will be 50.
3. I, Steve Kasperski understand that the driveways are to be plowed when snowfall is 4" or more. (Questionable snowfalls or accumulation of snow will be discussed with the Service Director.)
4. I, Steve Kasperski understand that the driveways will be plowed only once in a 24-hour period.
5. I, Steve Kasperski understand that the Village will notify me of any extended periods of time when a residence will not be home and not need plowing.
6. I, Steve Kasperski understand that I will not be liable for damage to driveways, curbs and lawns or spring clean up of debris due to winter plowing.

- I understand that the Village will only plow my driveway ONCE within a 24-hour period.
- I understand that the Village is to be notified of any extended periods of time (more than one week) when I will not be in residence, or of any new persons added to the household during the snow removal service period.
- I understand that the Village or contractor shall not be liable for damage to driveway, curbs, and lawns or spring clean up of debris due to winter plowing.
