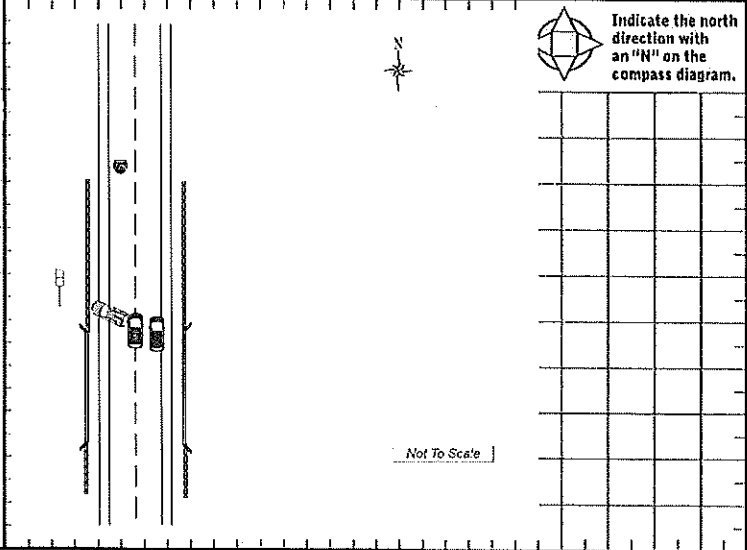

Unit 2 was on 77N at the 145.8 disabled from a previous crash (2022032) and as partially in the left lane facing West with 4 way flashers on and driver outside of the vehicle on the back side of the guard-rail.

Unit 1 was northbound on IR77 in the left when he came up on Unit 2. Unit 1 was attempting to merge into the right lane but was unable to get completely over do to another vehicle next to him not being able to move over do to snow piled up on the burm. Unit 1's left front then made contact with the right rear of Unit 2

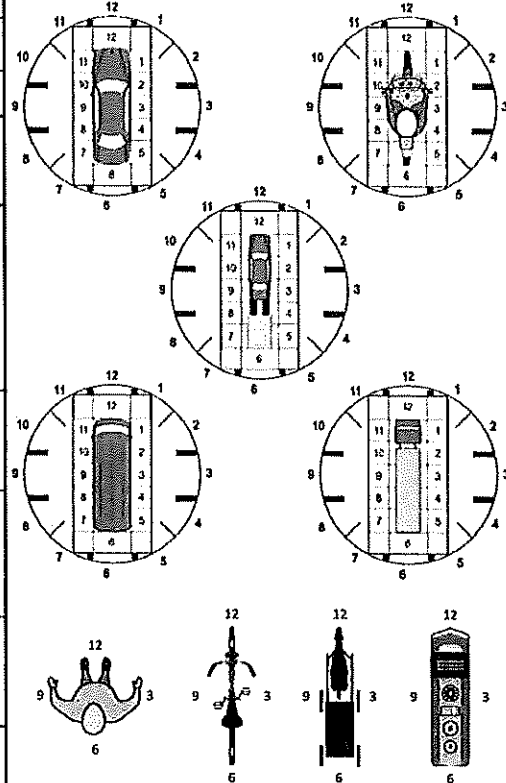

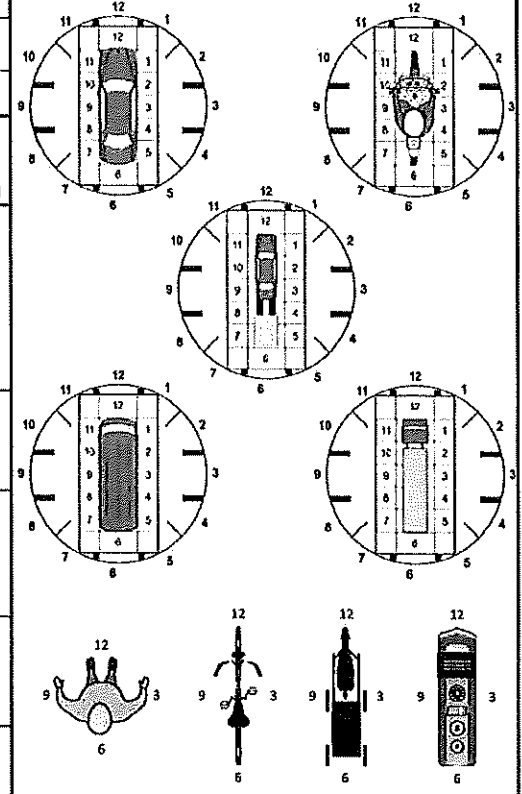
