

**A RESOLUTION TO MAKE RE-APPROPRIATIONS AND ADDITIONAL APPROPRIATIONS FOR OTHER EXPENDITURES OF THE VILLAGE OF RICHFIELD, STATE OF OHIO DURING THE YEAR ENDING DECEMBER 31, 1996**
