

AN ORDINANCE TO AUTHORIZE AND DIRECT THE MAYOR AND DIRECTOR OF FINANCE TO ENTER INTO A CONTRACT WITH THE TOWNSHIP OF RICHFIELD WITH RESPECT TO PROVIDING AN ATHLETIC PROGRAM AND DECLARING AN EMERGENCY.

Be It Ordained by the Council of the Village of Richfield, County of Summit, and State of Ohio:

Section 1: The Mayor and Director of Finance are authorized and directed to enter into an agreement with the Township of Richfield with respect to a recreational program.

Section 2: The form of the contract, now on file in the office of the Director of Public Service, is hereby approved.


Section 3: This Ordinance is determined to be an emergency measure necessary for the immediate preservation of the public peace, health, or safety for the reason to provide authority for contract action, and, provided this Ordinance receives the affirmative vote of two-thirds of the members elected or appointed, it shall take effect and be in force from and after its approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest date provided by law.

A G R E E M E N T .

The VILLAGE OF RICHFIELD, OHIO (Village), and the TOWNSHIP OF RICHFIELD, OHIO (Township), both in Summit County, agree as follows:

- 1) The Village will provide and maintain a baseball program for the purpose of providing recreational facilities.
- 2) The Village will provide and pay for facilities, personnel, trophies and all other costs and expenses for the program.
- 3) The program will be made available during the usual and ordinary months of the baseball season.
- 4) The Village will open the program to residents of the Township.
- 5) The Township will, for and on behalf of the Township residents who participate in the program, pay the actual cost of the Township participation in the program for 1987.
- 6) The Director of Finance will within a reasonable time after the close of the program provide a full and complete accounting of the program to the Township and the Township will, within forty-five days thereafter, pay to the Village the actual cost of Township participation.
- 7) This Agreement is subject to adjustment by mutual consent.
- 8) This Agreement is made pursuant to the terms of the Village Ordinance 35-1987, and the Township Resolution _____.

9) The Township of Richfield represents that the funds necessary to pay the obligation created by this Agreement are on deposit or have been appropriated and are in the process of collection.

10) This Agreement supersedes any prior agreement made by the Village and Township with respect to the program.
