AN ORDINANCE TO AUTHORIZE AND DIRECT THE MAYOR AND DIRECTOR OF FINANCE TO ENTER INTO AN AGREEMENT OF CONCURRENCE WITH THE OHIO DEPARTMENT OF TRANSPORTATION WITH RESPECT TO DETOUR OF MOTOR VEHICLE TRAFFIC AND DECLARING AN EMERGENCY.

WHEREAS, the Ohio Department of Transportation has advised this Village of detours required by the closing of two bridges within this Village and solicits the concurrence of this Village,


Therefore, Be It Ordained by the Council of the Village of Richfield, Ohio:

- Section 1: The Mayor and Director of Finance are authorized and directed to enter into an agreement with the Ohio Department of Transportation with respect to concurring in the plan of detours.
- Section 2: The form of the agreement, now on file in the office of the Director of Public Service, is approved.
- Section 3: This Ordinance is determined to be an emergency measure necessary for the immediate preservation of the public peace, health, or safety for the reason to cooperate in order to adjust for detour of motor vehicle traffic and provided this Ordinance receives the affirmative vote of two-thirds of the members elected or appointed, it shall take effect and be in force from and after its approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest date provided by law.
