**AN ORDINANCE TO AMEND ORDINANCE NO. 88-2012 TO MODIFY THE 2013 SCHEDULE OF POSITIONS, SALARY RATES AND WAGES TO OTHERWISE FIX AND DETERMINE COMPENSATION FOR A PART TIME SAFETY TOWN ASSISTANT COORDINATOR POSITION IN THE POLICE DEPARTMENT OF THE VILLAGE OF RICHFIELD.**

Be it ordained by the Council of the Village of Richfield, Ohio, State of Ohio:

SECTION 1. That Ordinance No. 88-2012 be amended in the following respects only, in order to incorporate a part time Safety Town Assistant Coordinator position in the Police Department:

The Finance Department requests first reading at the February 19, 2013 Council meeting of an Ordinance to amend Ordinance No. 88-2012 to modify the 2013 Schedule of Positions, Salary Rates and Wages to fix and determine compensation for a part time Safety Town Assistant Coordinator in the Police Department.

The Police Department has been utilizing a part time employee for many years but it has come to our attention that the position does not exist on the Schedule of Positions. This ordinance would modify the schedule of positions and compensation to reflect this position in the Police Department. The position's annual, bi-weekly, and hourly compensation ranges remain the same as other part time positions in the Recreation Department, Senior Center, which is an hourly rate of "minimum wage to \$19.43". The Police Department intends to pay the individual \$11.09 an hour.
