**A RESOLUTION TO MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF RICHFIELD, STATE OF OHIO, DURING THE YEAR ENDING DECEMBER 31, 2013**

**Be it resolved by the Council of the Village of Richfield, Ohio:**

**Section 1. To provide for the current expenses and other expenditures of said Village of Richfield during the year ending December 31, 2013, the following sums be and they are hereby set aside and appropriated as follows:**

**Section 2. That there be appropriated from the GENERAL FUND:**

a) **Police Department:**  
**Cost of Operations** **\$ 55,000.**

b) **Community Environment:**  
**Cost of Operations** **\$ 3,375.**

**TOTAL GENERAL FUND** **\$ 58,375.**

**Section 3. That there be appropriated from the STREET MAINTENANCE & REPAIR FUND:**

**Cost of Operations** **\$ 10,000.**

**Section 4. That there be appropriated from the FIRE EQUIPMENT FUND:**

**Cost of Operations** **(\$ 41,400.)**  
**Capital Equipment** **\$ 65,320**

**TOTAL FIRE EQUIPMENT FUND** **\$ 23,920.**

**Section 5. That there be appropriated from the BRECKSVILLE RD. PAVING FUND:**

**Cost of Operations** **\$308,300.**

**Section 6. That there be appropriated from the CAPITAL IMPROVEMENTS FUND:**

**Cost of Operations** **(\$250,000.)**

**Section 7. That there be appropriated from the INCOME TAX FUND, TRANSFERS TO:**

**Capital Improvement Fund** **(\$189,563.)**  
**Brecksville Rd. Paving Fund** **\$189,563.**

Section 8.	That there be appropriated from the CONTRACTOR INSPECTION/DEPOSITS FUND:	
	Cost of Operations	\$ 1,500.
Section 9.	That there be appropriated from the CAPITAL IMPROVEMENT FUND:	
	Cost of Operations	(\$ 98,800.)
	GRAND TOTAL – ALL APPROPRIATIONS	\$ 53,295.

Section 10. The Director of Finance is hereby authorized to draw warrants on the Village for payments for any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an Ordinance or Resolution of Council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with the law or Ordinance.

Section 11. In accordance with Section 4.12 of the Charter of the Village of Richfield, this Resolution shall take effect and be in force upon the approval of the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
