

AN ORDINANCE TO AUTHORIZE THE PAYMENT OF
COMPENSATION TO CERTAIN EMPLOYEES AND
DECLARING AN EMERGENCY.

WHEREAS, the Home Rule Powers set forth in the
Constitution of the State of Ohio empower municipalities to fix
and determine salaries and compensation to employees, and

WHEREAS, it is the intent of Council to increase
on a one time basis the compensation of certain Village employees
for the year 1983,

NOW, THEREFORE, Be it Ordained by the Council of
the Village of Richfield, Ohio:

Section 1: The Mayor and Director of Finance are authorized
to pay each full-time and permanent part-time
Village employee the sum of \$500.00. Employees
are named on the attached schedule.

Section 2: The Mayor and Director of Finance are authorized
to pay to each part-time patrolman and dispatcher
who has worked in excess of 350 hours between
January 1, 1983 and June 30, 1983 the amount of
\$200.00. Employees are named on the attached
schedule.



Section 3: The Mayor and Director of Finance are authorized
to pay the sum of \$200.00 to the part-time janitor
and the part-time Recreation Director.


Section 4: The sum set forth in Section 1, hereof is in addition
to and not in limitation of any sums set forth in
any other Ordinance or Resolution with respect to
compensation.

Section 5: The compensation paid pursuant to Section 1, hereof
shall be drawn from the Estate Tax distributions
received by this Village.

Section 6: This Ordinance is determined to be an emergency
measure necessary for the immediate preservation
of the public peace, health or safety for the
reason of compensating certain employees and
provided this Ordinance receives the affirmative
vote of two-thirds of the members elected or
appointed, it shall take effect and be in force
from and after its approval by the Mayor; otherwise,
it shall take effect and be in force from and after
the earliest date provided by law.
