

AN ORDINANCE TO ADOPT A SCHEDULE OF COMPENSATION FOR VILLAGE PERSONNEL, TO REPEAL ORDINANCE 63-1981 AND ORDINANCES AND SCHEDULES AND DECLARING AN EMERGENCY.

Be It Ordained by the Council of the Village of Richfield, Ohio:

Section 1: Schedule of Positions, Salary Rates, and Wages:  
The schedule of compensation, bearing a date of March 1, 1982 attached hereto and made a part hereof and the pay periods for officers, employees and members of Boards and Commissions shall be in accordance therewith from and after March 1, 1982.

Section 2: All other Ordinances or parts or sections or schedules thereto which are not consistent with the terms of this Ordinance are hereby repealed.

Section 3: This Ordinance is determined to be an emergency measure necessary for the immediate preservation of the public peace, health, or safety for the reason to provide compensation for Village employees and provided this Ordinance receives the affirmative vote of two-thirds of the members elected or appointed it shall take effect and be in force from and after its approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest date provided herein.
