



AN ORDINANCE TO AUTHORIZE ANNEXATION OF CERTAIN
TERRITORY TO THE VILLAGE OR RICHFIELD, SUMMIT
COUNTY, OHIO, AND DECLARING AN EMERGENCY.

Be It Ordained by the Council of the Village
of Richfield, Ohio:

- Section 1: Council determines, not less than a majority concurring, that the annexation of the property described in Section 2 of this Ordinance, all of which is contiguous to the Village of Richfield and all of which is unincorporated, shall be and hereby is authorized.
- Section 2: The property to be annexed is described as all of the unincorporated area of Richfield Township, Summit County, Ohio, that is, all of Richfield Township except that territory which now is embraced within the Village of Richfield and is described in the appendix to this Ordinance No. 27-1982.
- Section 3: The Director of Law is hereby authorized to prosecute the proceedings necessary to effect such annexation.
- Section 4: This Ordinance is determined to be an emergency measure necessary for the immediate preservation of public peace, health or safety for the reason to provide the orderly growth of this Village and provided this Ordinance receives the affirmative vote of two-thirds of the members elected or appointed it shall take effect and be in force from and after its approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest date provided by law.

APPENDIX

1. That the following is an accurate description of the territory embraced within the municipal corporation:
 - Situated in the original Township of Richfield, County of Summit, and State of Ohio, and bounded and described as follows:
 - Beginning at a point on the South line of said Township at the intersection of the centerline of Everett Road with the centerline of Revere Road;
 - A Thence North along the centerline of Revere Road to the centerline of Wheatley Road;
 - B Thence West along the centerline of Wheatley Road to a point 400 feet East of (measured at right angles to) the centerline of Cleveland-Massillon Road;
 - C Thence North parallel to and 400 feet East of (measured at right angles to) the centerline of Cleveland-Massillon Road to a point 400 feet South of (measured at right angles to) the centerline of Streetsboro Road (S.R. 303);
 - D Thence East parallel to and 400 feet South of (measured at right angles to) the centerline of Streetsboro Road about 3300 feet to the West line of lands now or formerly owned by T. & M. Monegan in Richfield Township, Lot 12, Tract 6;
 - E Thence North along the West line of lands now or formerly owned by said Monegan to the centerline of Streetsboro Road;
 - F Thence West about 200 feet along the centerline of Streetsboro Road to the West line of lands now or formerly owned by W. & G. Rose in Richfield Township, Lot 8, Tract 6;
 - G Thence North along the West line of lands now or formerly owned by said Rose 1028.82 feet to the Northwest corner thereof (being also in a South line of Hawthorne Estates, Plat Book 54, Pages 22-24);
 - H Thence East along the South line of Hawthorne Estates (Plat Book 54, Pages 22-24) 1153 feet to the Southeast corner thereof;
 - I Thence North along the East line of said Hawthorne Estates (Plat Book 54, Pages 22-24) to the North line of Lot #8, Tract #6;
 - J Thence West along a North line of said Hawthorne Estates (Plat Book 54, Pages 22-24) to the East line of Lot #16 in said Hawthorne Estates (Plat Book 54, Pages 22-24);
 - K Thence North to the Northeast corner of said Lot #16 in said Hawthorne Estates (Plat Book 54, Pages 22-24);

L Thence West along the most Northerly line of said Hawthorne Estates (Plat Book 54, Pages 22-24) to the Northwest corner of said Hawthorne Estates (Plat Book 54, Pages 22-24); which is also a point in the North line of Township Lot #2, Tract #4;

M Thence continuing West along the North line of Township Lot #2, Tract #4 to a point 400 feet East of (measured at right angles to) the centerline of Cleveland-Massillon Road;

N Thence North, parallel and concentric to and 400 feet East of (measured at right angles to) the centerline of Cleveland-Massillon Road, to a point in the South line of lands now or formerly owned by I. J. Nank in Lot #8, Tract #4 of original Richfield Township;

O Thence East along the South line of lands now or formerly owned by I. J. Nank and the South line of Farnham Acres (Plat Book 56, Page 40) to a Southeast corner of Lot #D-2 therein and the East line of Richfield Township Lot #8, Tract #4;

P Thence North along the East line of Lot #D-2 and the East line of Lot #D-1 in said Farnham Acres (Plat Book 54, Page 40) to the Northeast corner of said Lot #D-1 in said Farnham Acres (Plat Book 56, Page 40);

Q Thence West along the North line of said Farnham Acres (Plat Book 56, Page 40) and along the North line of lands now or formerly owned by F. & L. Theiss to a point 400 feet East of (measured at right angles to) the centerline of Cleveland-Massillon Road;

R Thence North parallel and concentric to and 400 feet East of (measured at right angles to) the centerline of Cleveland-Massillon Road, to the North line of original Richfield Township and Summit County;

S Thence West along the North line of Richfield Township and Summit County to the Northwest corner of original Richfield Township Lot #12, Tract #4;

T Thence South along the West lines, of original Richfield Township Lots 12, 11, 10, 9, 8, 7, 6, and 5 of Tract #4 to the Southeast corner of original Richfield Township Lot #11, Tract #1;

U Thence West along the South line of original Richfield Township Lot #11, Tract #4 to the Southwest corner thereof;

V Thence North along the East line of original Richfield Township Lot #12, Tract #1, 500 feet to a point;

W Thence West parallel to the South line of original Richfield Township Lots 12, 13 and 14 to a point in the centerline of West Richfield Road (S.R. #176);

X Thence Southeast along the centerline of said West Richfield Road to the West line of original Richfield Township Lot #18, Tract #1;

Y Thence South along the West line of original Richfield Township Lots 18 and 23, Tract #1 to the Northeast corner of Ridgeview Subdivision (Plat Book 46, Pages 41 and 42);

Z Thence West on its Northerly line to the Northwest corner of said Ridgeview Subdivision (Plat Book 46, Pages 41 and 42);

1 Thence South along the West line of said Ridgeview Subdivision (Plat Book 46, Pages 41 and 42) to the centerline of Streetsboro Road;

2 Thence East along the centerline of Streetsboro Road to the West line of original Richfield Township Lot #8, Tract #2;

Thence South along the West line of original Richfield Township Lot #8, Tract #2, to the North line of original Richfield Township Lot #13, Tract #2 (being also the North line of Vozobule Allotment, Plat Book 45, Page 211);

Thence West along the North line of original Richfield Township Lot #13, Tract #2, to the Northwest corner thereof (being also the Northwest corner of Vozobule Allotment, Plat Book 45, Page 211);

Thence South along the West line of original Richfield Township Lot #13, Tract #2, and the West line of Vozobule Allotment (Plat Book 45, Page 211), to the Southwest corner of Vozobule Allotment (Plat Book 45, Page 211);

Thence East along the South line of said Vozobule Allotment (Plat Book 45, Page 211) to a point 400 feet West of (and measured at right angles to) the centerline of Southern Road;

Thence South parallel to the centerline of Southern Road to a point 400 feet North of (and measured at right angles to) the centerline of Hawkins Road;

Thence West parallel to the centerline of Hawkins Road to a point which is the North Extension of the most Westerly line of Overdale Acres (Plat Book 45, Pages 198-199);

Thence South along said extension line and said West Allotment line to the Southwest corner of Lot #14 in said Overdale Acres (Plat Book 45, Pages 198-199);

Thence East along the South line of Lot #14 in said Overdale Acres (Plat Book 45, Pages 198-199) to the Northwest corner of Lot #13 in said Overdale Acres (Plat Book 45, Pages 198-199);

Thence South along the West line of said Overdale Acres (Plat Book 45, Pages 198-199) to the Southwest corner of Lot #12 in said Overdale Acres (Plat Book 45, Pages 198-199);

Thence East along the South line of said Overdale Acres (Plat Book 45, Pages 198-199) to the centerline of Southern Road;

Thence North along the centerline of Southern Road to a point in the South line of original Richfield Township Lot #15, Tract #2;

Thence East along the South line of original Richfield Township Lot #15, Tract #2, to the Southeast corner thereof;

Thence South along the East line of original Richfield Township Lots 16, 17, and 18, Tract #2, to a point in the South line of original Richfield Township;

Thence East along the South line of original Richfield Township to the centerline of Revere Road, and the place of beginning.
