

AN ORDINANCE TO AUTHORIZE AND DIRECT THE  
MAYOR AND DIRECTOR OF FINANCE TO ENTER  
INTO A CONTRACT WITH EAST OHIO GAS COMPANY  
FOR THE PURCHASE OF NATURAL GAS.

WHEREAS, a new rate has been proposed by the  
East Ohio Gas Company and the new rate is lower  
than the existing rate charged by the East  
Ohio Gas Company for the supplying of natural  
gas to the facilities and buildings of this  
Village, and

WHEREAS, it is in the interest of the Village to  
keep fuel costs at a minimum, therefore

Be It Ordained by the Council of the Village of  
Richfield, Ohio:

Section 1: The Mayor and Director of Finance are authorized  
and directed to enter into a contract with the  
East Ohio Gas Company for the providing of  
natural gas to the facilities owned or controlled  
by the Village of Richfield.

Section 2: The form of the contract now on file in the  
office of the Director of Public Service is  
hereby approved.

Section 3: This Ordinance shall take effect and be in force  
from and after the earliest date provided by  
law.

ELECTION

After reviewing these schedules, the undersigned hereby elects to purchase gas from East Ohio pursuant to rate schedule P.U.C.O. No. 500A, as said rate schedule shall be in effect from time to time.

APPLICATION, CONTINUATION AND CHANGE OF THIS ELECTION

This election relates only to the rate schedule at which the undersigned will receive gas from East Ohio and otherwise will not affect or alter the terms and conditions under which East Ohio is presently supplying gas to the undersigned.

The election herein made by the undersigned shall continue as long as P.U.C.O. No. 500A or any successor rate schedule remains in effect and shall not be subject to change during such time except in accordance with the terms of P.U.C.O. No. 500A. The undersigned shall not be free to elect to receive service under a rate schedule other than P.U.C.O. No. 500A except in accordance with the terms of both such newly elected rate schedule and P.U.C.O. No. 500A.

ENTIRE AGREEMENT

This writing supersedes any prior oral or written understanding between the parties hereto relating to the matters covered herein and represents their entire contract relating to such matters, and no subsequent oral agreement shall modify or amend this writing.
