

A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR AND THE FINANCE DIRECTOR TO ENTER INTO AN AGREEMENT WITH SNIDER RECREATION, INC FOR PLAYGROUND EQUIPMENT AT RICHFIELD WOODS PARK (STATE CONTRACT NO. 800702) AND DECLARING AN EMERGENCY


WHEREAS, this Council desires to authorize the Mayor and Finance Director to enter into a purchase agreement with Snider Recreation, Inc., for playground equipment at Richfield Woods Park at state contract pricing (State Contract No. 800702) in an amount not to exceed \$110,888.00, in accordance with the proposal attached hereto as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, County of Summit, State of Ohio that:

- SECTION 1. The Mayor and Finance Director are hereby authorized to enter into a purchase agreement with Snider Recreation, Inc., for playground equipment at Richfield Woods Park at state contract pricing (State Contract No. 800702) in an amount not to exceed \$110,888.00, in accordance with the proposal attached hereto as Exhibit A.
- SECTION 2. Because this purchase is made under the State of Ohio Cooperative Purchasing Program, Council waives the requirement for competitive bidding pursuant to Section 141.03(f) of the Richfield Codified Ordinances
- SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
- SECTION 4. This Resolution is hereby declared to be an emergency measure for the reason that it is immediately necessary to execute the purchase agreement and mobilize the contractor for the construction of the new playground; wherefore, this Resolution shall take immediate effect, provided that it receives the requisite number of votes needed to pass as an emergency measure; otherwise, it shall take effect at the earliest date allowed by law.
