

RESOLUTION NO. 6-2021

Offered by All of Council

A RESOLUTION ESTABLISHING A TEMPORARY MORATORIUM ON THE SALE OF BURIAL PLOTS IN LOTS 30, 31, 34, AND 35 IN THE NEW ADDITION OF FAIRVIEW CEMETERY IN ORDER TO ALLOW THE VILLAGE THE STUDY THE FEASIBILITY OF CONSTRUCTING A COLUMBARIUM, AND DECLARING AN EMERGENCY.

WHEREAS, the Village is exploring the feasibility of constructing a columbarium in the new addition of Fairview Cemetery; and

WHEREAS, the Director of Public Service has indicated that the most likely location of the columbarium would be the current location of lots 30, 31, 34, and 35 in the new addition of Fairview Cemetery as indicated in the attached Exhibit A; and

WHEREAS, a temporary moratorium on the sale of burial plots in lots 30, 31, 34, and 35 in the new addition of Fairview Cemetery is necessary in order to allow the Village sufficient time to study the feasibility of constructing the columbarium and to allow construction of the columbarium should it be feasible to do so.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, County of Summit that:


SECTION 1. This Council establishes a temporary moratorium on the sale of burial plots in lots 30, 31, 34, and 35 of the new addition of Fairview Cemetery for a period of one (1) year from the date of passage of this Resolution in order to allow the Village to study the feasibility of constructing a columbarium and construction of the columbarium should it be feasible to do so.

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


SECTION 3. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to establish the moratorium for the reasons set forth in the recital of this Resolution; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

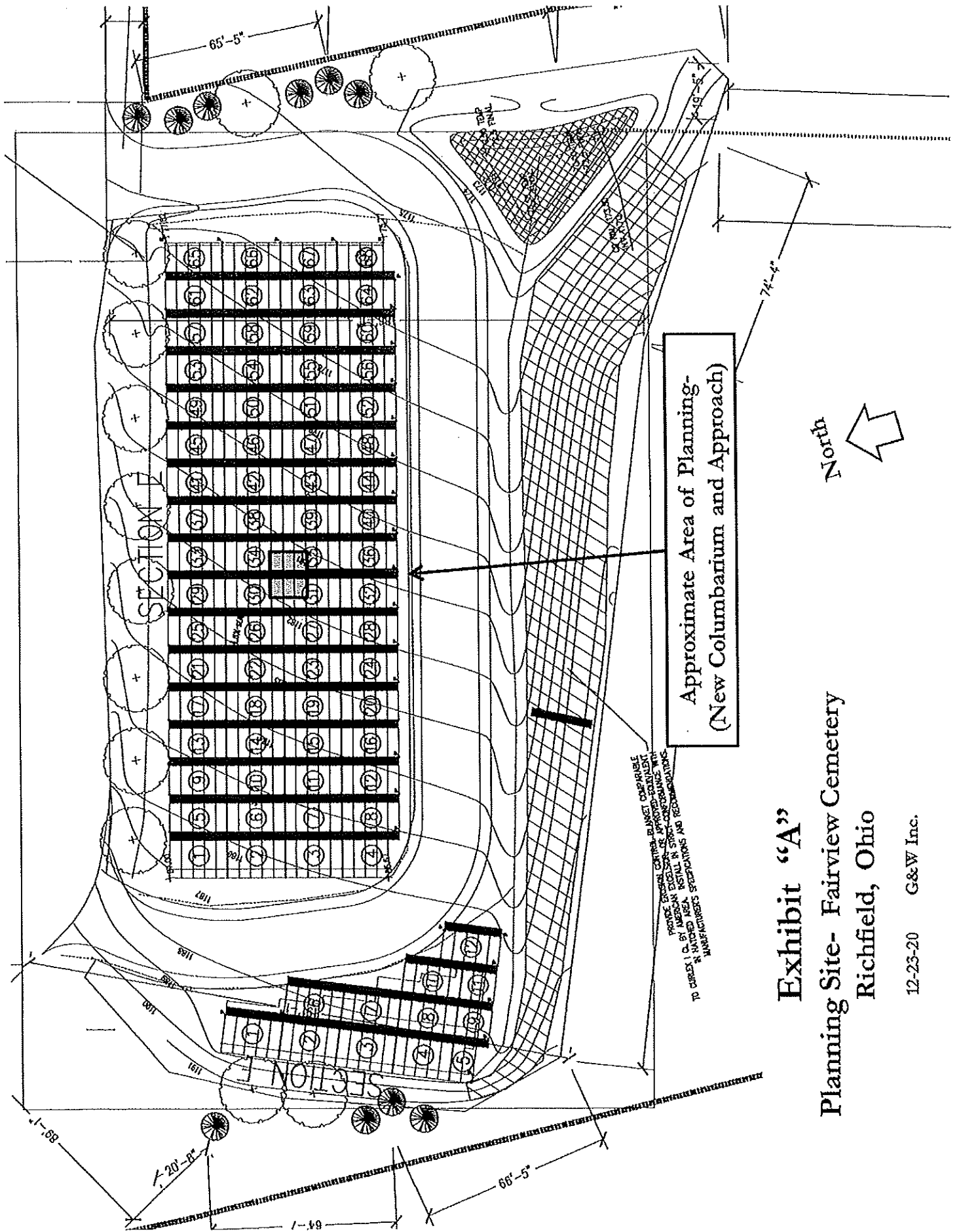
