

**A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR AND FINANCE DIRECTOR TO ENTER INTO A FIRST RENEWAL OF THE SUMMIT COUNTY-AKRON REGIONAL RADIO SYSTEM USER AGREEMENT, AND DECLARING AN EMERGENCY**

WHEREAS, the Village is a party to the Summit County-Akron Regional Radio System User Agreement ("Agreement") by and among Summit County, the City of Akron, and the Village of Richfield; and

WHEREAS, Village desires to enter into a First Renewal of the Agreement under terms and conditions substantially similar to the Agreement attached hereto as Exhibit A.

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio that:


SECTION 1. The Mayor and the Finance Director are authorized and directed to enter a First Renewal of the Summit County-Akron Regional Radio System User Agreement substantially in accordance with the agreement attached hereto as Exhibit A and incorporated herein fully as if by reference.

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to ensure that there is no disruption in the radio services utilized by the Village; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

**FIRST RENEWAL  
OF THE  
SUMMIT COUNTY-AKRON  
REGIONAL RADIO SYSTEM  
USER AGREEMENT**

This First Renewal of the Summit County-Akron Regional Radio System User Agreement, effective May 1, 2024, is by and among the COUNTY OF SUMMIT, Office of the County Executive, 175 South Main Street, 8th Floor, Akron, Ohio 44308 (the “County”), as authorized by County Council Resolution No. 2018-381, and the CITY OF AKRON, Mayor’s Office, Municipal Building, 166 South High Street, Akron, Ohio 44308 (the “City”), as authorized by City of Akron Ordinance No. 498-2005 (collectively, the “Owners”), and VILLAGE OF RICHFIELD, with its principal place of business at 4410 West Streetsboro Road, Richfield, Ohio 44286 (“User”) (the Owners and User together, the “Parties”).

**RECITALS**

**WHEREAS**, the Owners and User entered into the Summit County-Akron Regional Radio System User Agreement (the “Agreement”), effective as of May 1, 2019; and

**WHEREAS**, the Agreement’s initial term expired on April 30, 2024, with options for renewal; and

**WHEREAS**, the Parties desire to renew the Agreement for an additional five-year term in accordance with the terms outlined in Section 4 of the Agreement.

**NOW, THEREFORE**, in consideration of the mutual promises contained herein, the parties agree as follows:

**1. Renewal Term**

The Agreement is hereby renewed for an additional term of five (5) years, commencing on May 1, 2024, and expiring on April 30, 2029, pursuant to the renewal option provided in Section 4 of the Agreement.

**2. Terms and Conditions**

All other terms and conditions of the Agreement shall remain in full force and effect, unless modified herein or in a subsequent written agreement signed by all Parties.

**3. Updated Membership Fees**

The membership fee for the renewal term shall be \$20.00 per month, per radio.

**4. Notices**

Notices for the renewal term shall continue to be sent to the addresses outlined in the original Agreement unless otherwise updated in writing by a party.

**5. Acknowledgment of Renewal**

By signing below, the Parties affirm their intention to continue their participation under the terms of the Agreement as renewed herein.

**IN WITNESS WHEREOF**, the parties have executed this Renewal Agreement for the Summit County-Akron Regional Radio System as of the date first written above.
