A RESOLUTION TO MAKE AN APPROPRIATION TRANSFER AND APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF RICHFIELD, STATE OF OHIO, DURING THE YEAR ENDING DECEMBER 31, 2025, AND DECLARING AN EMERGENCY

NOW, THEREFORE, be it resolved by the Council of the Village of Richfield, Summit County, State of Ohio:

Section 1. To provide for the current expenses and other expenditures of said Village of Richfield during the year ending December 31, 2025, the following sums be, and it is hereby set aside and appropriated as follows:

Section 2. That there be an appropriation transfer from the **General Fund**:

A. Police Department

Section 3. That there be appropriated from the **Drug Law Enforcement Fund**:

Cost of Operations		(\$18,000)
TOTAL Drug Law Enforcement Fund:		(\$18,000.00)

Section 4. That there be appropriated from the **Law Enforcement Trust Fund**:

Cost of Operations		(\$2,000)
TOTAL Law Enforcement Trust Fund:		(\$2,000.00)

Section 5. That there be appropriated from the **Capital Improvements Fund**:

Cost of Operations		(\$1,300,000)
TOTAL Capital Improvement Fund:		(\$1,300,000.00)

Section 6. That there be appropriated from the **Tax Increment Equivalent Fund**:

Cost of Operations		(\$1,173,000)
TOTAL Tax Increment Equivalent Fund:		(\$1,173,000.00)

GRAND TOTAL – ALL APPROPRIATIONS (\$2,493,000.00)

Section 7. The Director of Finance is hereby authorized to draw warrants on the Village for payments for any of the foregoing appropriation upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an

Ordinance or Resolution of Council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with the law or Ordinance.

Section 8. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulting in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 9. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents of the Village of Richfield, County of Summit, State of Ohio and for the further reason that it is immediately necessary in order to pay for services rendered; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
