

A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR AND THE FINANCE DIRECTOR TO ENTER INTO A CONTRACT WITH AXON ENTERPRISE, INC. FOR BUNDLED TASER SERVICES FOR A PERIOD OF 60 MONTHS, WAIVING COMPETITIVE BIDDING TO THE EXTENT APPLICABLE, AND DECLARING AN EMERGENCY

WHEREAS, the Village desires to purchase bundled TASER services from Axon Enterprises, Inc. for a period of 60 months for use by the Village Police Department in accordance with the fee schedule set forth in the quote attached hereto as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, County of Summit, State of Ohio that:

- SECTION 1. The Mayor and Finance Director are hereby authorized and directed to enter into a contract with Axon Enterprise, Inc. for the provision of bundled TASER services for a term of 60 months, at a price not to exceed the total sum of \$100,676.00 with such contract subject to final approval from the Director of Law.
- SECTION 2. Council waives the requirement for competitive bidding pursuant to Section 141.03(f)(5) of the Richfield Codified Ordinances because of the bundled TASER services purchased are incapable of being competitively bid.
- SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
- SECTION 4. This Resolution is hereby declared to be an emergency measure for the reason that it is immediately necessary to purchase and upgrade the Village's servers and corresponding licenses to ensure the Village's Police Department continues to operate in an efficient manner; wherefore, this Resolution shall take immediate effect, provided that it receives the requisite number of votes needed to pass as an emergency measure; otherwise, it shall take effect at the earliest date allowed by law.
