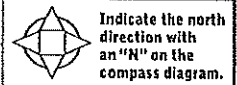

Traffic was very slow moving on 271-S due to a crash at the 8.5mm. Drivers of units 1 and 2 were in stop and go traffic around the 9.8, southbound. While stopped in the left lane, unit 1 let off the brake, rolling backward and striking unit 2. This portion of roadway is on an uphill grade. Both then exited the roadway waited on the righthand apron. Driver of unit 1 was cited for ORC 4511.38 - Improper starting and backing.
