

ORDINANCE NO. 58-2005

AN ORDINANCE PETITIONING SUMMIT COUNTY COUNCIL TO CHANGE THE BOUNDARY LINES OF RICHFIELD TOWNSHIP TO CONFORM WITH THE CURRENT CORPORATE LIMITS OF THE VILLAGE OF RICHFIELD, PURSUANT TO R.C. §503.07 AND DECLARING AN EMERGENCY

WHEREAS, pursuant to R.C. §503.07, the majority of members of the legislative authority of the Village of Richfield desire to petition Summit County Council to conform the boundaries of Richfield Township and to make the common boundaries of said Richfield Township identical with the corporate limits of the Village of Richfield; and

WHEREAS, by reason of annexation of portions of Richfield Township, it is desirable that the boundaries of Richfield Township be changed to conform with the current corporate limits of the Village of Richfield pursuant to previous legislation accepting each proposed annexation. The annexations in question are fully described in the Ordinances as set forth in Exhibit A.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Richfield, Summit County, State of Ohio:

- SECTION 1. That this Council pursuant to R.C. §503.07 does hereby petition Summit County Council requesting a change in boundary lines identical with the current corporate limits of the Village of Richfield in accordance with the above-referenced legislation accepting each proposed annexation from territory previously within Richfield Township, as more fully described in Exhibit A attached hereto and incorporated by reference. Said ordinances, which are incorporated by reference and attached hereto are not deemed exclusive, in that the conformity sought pertains to all annexations, regardless of time annexed, such having been the original intent of the parties. The Clerk of Council is hereby directed to submit this legislation to the Clerk of Summit County Council at the earliest date allowed by law.
- SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- SECTION 3. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, welfare, and safety and for the further reason that it is immediately necessary to forward to Summit County prior to their September Council meeting so that the properties in question are doubly taxed; wherefore, provided this Resolution receives the affirmative vote of two-

thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
