

**A RESOLUTION AUTHORIZING THE MAYOR AND FINANCE
DIRECTOR TO ENTER INTO AN AGREEMENT WITH THE
VILLAGE OF PENINSULA FOR POLICE DISPATCHER SERVICES**

BE IT RESOLVED by the Council of the Village of Richfield, State of Ohio:

SECTION 1. That the Mayor and Finance Director be, and they hereby are, authorized and directed to enter into an agreement with the Village of Peninsula for Police dispatcher services, a copy of which agreement is attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. This Resolution shall take effect and be in force from and after the earliest period allowed by law.

EXHIBIT "A"

DISPATCHING AGREEMENT BETWEEN THE VILLAGE OF
RICHFIELD, OHIO AND THE VILLAGE OF PENINSULA, OHIO

Pursuant to R.C. 737.04 and 737.041 together with the exercise of the powers set forth in the Charter and the Constitution, this Agreement is signed this 19th day of June, 1998 by and between the Village of Richfield, Ohio ("Richfield"), and the Village of Peninsula, Ohio, ("Peninsula").

The parties agree as follows:

1. Richfield will provide 24-hour, seven day a week dispatching services for the Peninsula Police Department for the period beginning July 1, 1999 and continuing to June 30, 2002, both inclusive, or until this Agreement is rescinded by resolution of either party and upon a written 90-day notice.
2. Peninsula agrees to pay to Richfield the following installments:
 - A. 1st Year \$13,200.00
 - 1.) \$3,300.00 due 7/1/99 and 10/1/99
 - 2.) \$3,300.00 due 1/1/2000 and 4/1/2000
 - B. 2nd Year \$13,860.00
 - 1.) \$3,465.00 due 7/1/2000 and 10/1/2000
 - 2.) \$3,465.00 due 1/1/01 and 4/1/01
 - C. 3rd Year \$14,556.00
 - 1.) \$3,639.00 due 7/1/01 and 10/1/01
 - 2.) \$3,639.00 due 1/1/02 and 4/1/02
3. If requested by Peninsula, Richfield shall submit to Peninsula a schedule of dispatching services performed for the Peninsula Police Department.
4. For the purposes of this agreement, the Police Chief of Richfield and the Police Chief of Peninsula shall be the designated officials with authority to implement the agreement.
5. Peninsula agrees to hold the members of the Richfield Police Department, including its Chief of Police, Police Officers and dispatchers individually harmless from any and all liability that may arise in or from the dispatching services provided herein.

6. The term of this contract shall be from July 1, 1999 to and including June 30, 2002.
7. This contract is entered into pursuant to Resolution No. 50-1999 of the Village of Richfield and Resolution No. _____ - 1999 of the Village of Peninsula, Summit County, Ohio.
