

A RESOLUTION AUTHORIZING THE PURCHASE OF A REAR MOUNT FLAIL MOWER THROUGH THE STATE COOPERATIVE PURCHASING PROGRAM AND DECLARING AN EMERGENCY

WHEREAS, a bid was received to purchase an Alamo PA92 Rear Mount Flail Mower from Franklin Tractor Sales, Inc. through the State Cooperative Purchasing Program, a copy of which bid is attached hereto as Exhibit "A" and incorporated herein fully as if by reference; and

WHEREAS, the Service Director believes the quote is fair and reasonable; and

WHEREAS, funds have been appropriated for the purchase of the mower from the Capital Improvement Fund.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, State of Ohio:

SECTION 1. That there is hereby authorized the purchase of an Alamo PA92 Rear Mount Flail Mower at a cost of \$11,385.70 from Franklin Tractor Sales, Inc. through the State Cooperative Purchasing Program in accordance with the bid attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to be available for the upcoming mowing season; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

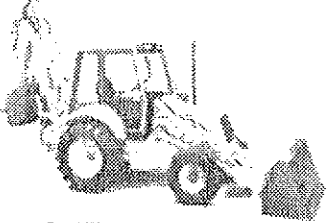
