A RESOLUTION AUTHORIZING THE PURCHASE OF A SKID LOADER THROUGH THE STATE COOPERATIVE PURCHASING PROGRAM AND DECLARING AN EMERGENCY

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, State of Ohio:

- SECTION 1. That there is hereby authorized the purchase of a New Holland LX665 Skid Loader from Franklin Tractor Sales, Inc. in an amount not to exceed \$17,270.80 in accordance with the bid attached hereto as Exhibit "A" and incorporated herein fully as if by reference through the State Cooperative Purchasing Program.
- SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to be ready for the upcoming construction season; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
