

A RESOLUTION ACCEPTING THE BID OF McCOURT CONSTRUCTION COMPANY FOR PAVING OF VARIOUS RESIDENTIAL STREETS AND DECLARING AN EMERGENCY

WHEREAS, pursuant to advertisement, bids were received on the 30th day of July, 1997, for paving of various streets; and

WHEREAS, the Service Director has recommended acceptance of the bid of McCourt Construction Company as being the lowest and best bid.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, State of Ohio:

SECTION 1. That the bid of McCourt Construction Company in the amount of \$111,496.00 for paving of various residential streets, being the lowest and best bid, be, and the same hereby is, accepted.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary to pave essential Village streets; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
