

**A RESOLUTION TO MAKE APPROPRIATIONS FOR CURRENT EXPENSES
AND OTHER EXPENDITURES OF THE VILLAGE OF RICHFIELD, STATE OF
OHIO, DURING THE QUARTER ENDING MARCH 31, 1995.**

BE IT RESOLVED by the Council of the Village of Richfield, Ohio, that to provide for the current expenses and other expenditures of said Village of Richfield, Ohio during the Quarter ending March 31, 1995, the following sums be and they are hereby set aside and appropriated as follows:

SECTION 1:	That there be appropriated from the GENERAL FUND	\$ 431,000
SECTION 2:	That there be appropriated from the STREET CONSTRUCTION, MAINTENANCE AND REPAIR FUND	175,000
SECTION 3:	That there be appropriated from the STATE HIGHWAY FUND	3,100
SECTION 4:	That there be appropriated from the CEMETERY FUND	3,000
SECTION 5:	That there be appropriated from the CAPITAL IMPROVEMENT FUND	50,000
SECTION 6:	That there be appropriated from the PARKS/RECREATION FUND	7,800
SECTION 7:	That there be appropriated from the INCOME TAX FUND	425,000
SECTION 8:	That there be appropriated from the SANITARY SEWER FUND	25,000
SECTION 9:	That there be appropriated from the LIBRARY OPERATING FUND	4,500
SECTION 10:	That there be appropriated from the SEWER OPERATION FUND	65,000
SECTION 11:	That there be appropriated from the OWDA - SEWER DISTRICT #1 FUND	5,000
SECTION 12:	That there be appropriated from the WATER IMPROVEMENT FUND	75,000

SECTION 13:	That there be appropriated from the ISSUE 2 GRANT/LOAN-WATER LINE	75,000
SECTION 14:	That there be appropriated from the CONTRACTOR RETAINER FUND	10,000
SECTION 15:	That there be appropriated from the WATER REVENUE FUND	1,000
SECTION 16:	That there be appropriated from the CDBG GRANT-HISTORIC DISTRICT	15,000
SECTION 17:	That there be appropriated from the ISSUE 2 GRANT-TRAFFIC SIGNAL ENGINEERING	1,500
TOTAL ALL APPROPRIATIONS		\$ 1,371,900.

SECTION 18: The Director of Finance is hereby authorized to draw warrants on the Village of Richfield for payment from any of the foregoing appropriations upon receiving proper certificates and vouchers therefor, approved by the Board or Officers authorized by Council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or Ordinance.

SECTION 19: In accordance with Section 4.12 of the Charter of the Village of Richfield, this Resolution No. 1-1995 shall take effect and be in force upon the approval by the Mayor.
