Be it Ordained by the Council of the Village of Richfield, Ohio:


**Section 1:** Schedule of Positions, Salary Rates, and Wages:


The schedule of positions and compensation, bearing a date of March 23, 1992 through March 21, 1993, attached hereto and made a part hereof and the pay periods for officers, employees, and members of Boards and Commissions shall be in accordance therewith from and after March 23, 1992.

**Section 2:** Ordinance No. 15-1991 is amended and all other Ordinances or parts or schedules which are not consistent with the terms of this Ordinance are hereby repealed.

**Section 3:** This Ordinance is determined to be an emergency measure necessary for the immediate preservation of the public peace, health or safety for the reason to provide compensation for Village employees and provided this Ordinance receives the affirmative vote of two-thirds of the members elected or appointed, it shall take effect and be in force from and after its approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest date provided by law.

A Part-time Police Officer will qualify for the Annual Uniform Allowance of \$250.00 in the Calendar year following his/her first year of service to the Village.
