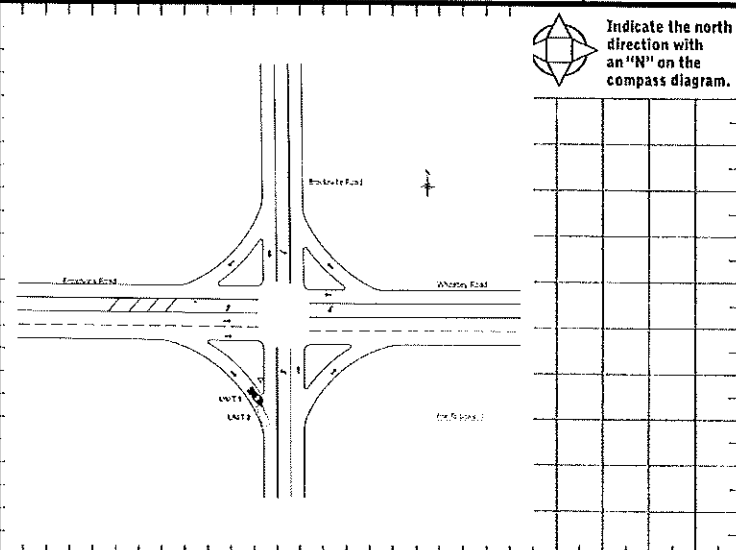

Unit 1 was behind Unit 2 and was looking over her left shoulder for southbound traffic. Driver of Unit 1 did not realize that Unit 2 had come to a complete stop. Unit 1 then accelerated and impacted Unit 2's left rear with the front of their vehicle.



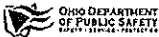
