

A RESOLUTION TO AUTHORIZE THE MAYOR AND DIRECTOR OF FINANCE TO ENTER INTO A CONTRACT WITH THE TOWNSHIP OF RICHFIELD FOR THE FURNISHING OF POLICE, FIRE, AND RESCUE DISPATCH SERVICE FOR THE TOWNSHIP OF RICHFIELD AND DECLARING AN EMERGENCY.

Be It Resolved by the Council of the Village of Richfield, Ohio:

SECTION 1: That the Mayor and Director of Finance are authorized to enter into an agreement with Richfield Township wherein the Village of Richfield shall furnish Police, Fire and Rescue Dispatch service to the Richfield Township.

SECTION 2: That the form of the agreement now on file in the office of the Director of Public Service is approved.

SECTION 3: That the Clerk is directed to forward a certified copy of this Resolution to the Clerk of Richfield Township and to the Police Chief and Fire Chief of the Village.

SECTION 4: This Resolution is determined to be an emergency measure necessary for the immediate preservation of the public peace, health, or safety for the reason to continue dispatching service and provided this Resolution receives the affirmative vote of two-thirds of the members elected or appointed, it shall take effect and be in force from and after its approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest date provided by law.

DISPATCHING AGREEMENT BETWEEN THE VILLAGE OF RICHFIELD,
OHIO, AND THE TOWNSHIP OF RICHFIELD, OHIO

Pursuant to Revised Code 505.44, 505,443 and 9.60 et. seq. together with the exercise of the powers set forth in the Charter and the Constitution, this Agreement is signed this _____ day of _____, 1989, by and between the Village of Richfield, Ohio referred to as the Village and the Township of Richfield, Ohio referred to as the Township.

The parties agree as follows: and fire

1. In order to provide police/protection to the residents of the Township of Richfield, the Village will provide 9-1-1- police dispatching services in conjunction with Summit County and Fire and Rescue Dispatching services in conjunction with the Fire Contract pursuant to Res. 5-1989 to Richfield Township for a period beginning March 1, 1989 and continuing to February 28, 1990 both inclusive, or until this Agreement is rescinded by resolution of either party and upon a written 90-day notice.
2. The Township agrees to pay the Village therefor the sum of Eight Thousand Dollars (\$8,000.), payable in quarterly installments due on the first day of March, June, September and December 1989.
3. After the close of the contract year, the Village shall submit to the Township a schedule of the dispatching services provided.
4. The Township agrees to hold the Village of Richfield and the members of the Village Police Department individually harmless from any and all liability that may arise as a result of the dispatching services contracted for herein.
5. The term of this Agreement shall be from March 1, 1989 to and including February 28, 1990.
6. This Agreement is entered into pursuant to Resolution #6-1989 of the Village of Richfield and Resolution _____ of the Township of Richfield, Summit County, Ohio.
