

**A RESOLUTION AUTHORIZING THE MAYOR AND THE FINANCE DIRECTOR TO ENTER INTO A CONTRACT WITH RUMPKE OF NORTHERN OHIO FOR TRASH AND RECYCLING SERVICES FOR THE YEARS 2023, 2024, AND 2025 WITH TWO ONE-YEAR RENEWAL OPTIONS, AND DECLARING AN EMERGENCY**

WHEREAS, Council adopted Resolution No. 19-2022 on April 13, 2022, authorizing the Director of Service to advertise for bids for trash hauling and recycling services for the Village for 2023-2025; and

WHEREAS, the Director of Service has evaluated the bids received by the Village and has recommended that the Village accept the bid of Rumpke of Northern Ohio.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio that:

- SECTION 1. The Mayor and the Finance Director be, and they hereby are, authorized and directed to enter into an agreement with Rumpke of Northern Ohio for trash and recycling services for the Village during the years 2023, 2024, and 2025, with two one-year renewal options in accordance with Bid Option No. 1 attached hereto as Exhibit "A" and incorporated herein fully as if by reference.
- SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- SECTION 3. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to be effective by January 1, 2023; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
